- Date of ACTIVATION of the Online Application for the post will be notified shortly. Candidates are advised to be in constant touch with the above website to apply for the post.
- Candidates are required to apply through online mode only after publication of detailed Advertisement in OSSC website.
- Candidates must go through the detail advertisement & ensure their eligibility before applying.
- Candidates on the basis of the information filled in the online application form will be allowed for different stages of examination and if at any stage it is found that he/she has furnished false or incorrect information his/her candidature will be rejected forthwith.
- Candidates have to download call letter from the above website for appearing the examination at different stages of recruitment. No call letter will be sent to candidates by post.
- Female candidates are eligible for the post of S.I. of Police & Asst. Jailor.
- PWD candidates are eligible to apply for the post.
- Only on-line applications are invited for the post. Candidates are required to submit DAF at the time of Viva Voce-cum-Psychological Test as per clause-6 of the detailed advertisement.

SCALE OF PAY The appointment will be initially on contractual basis carrying a consolidated pay comprising of initial pay+ grade pay in the scale of pay of Rs. Rs9300/- to 34,800/- and G.P. of Rs.4200/- P.B.-2 Rs.9300/- to 34800/- with Grade Pay Rs.4200/- (Pre-revised) to be modified by the Government from time to time.

CONDITIONS OF SERVICE: Appointment is guided by the Combined Competitive Recruitment Examination for Group-C Posts of Orissa Police Service, Orissa Fire Service Orders, 2008 & the Odisha Group-B (Contractual Appointment) Rules, 2013.

ELIGIBILITY

- Age:** Must not be below 21 years and above 25 years of age as on 1.1.2017.
- Upper age relaxation limit:** 5 years in case of ST, SC, SEBC and Women and period of service rendered in armed forces in case of Ex-SM. There is no age relaxation to In-Service Contractual Employees.
- Educational Qualification:** Must be a Graduate degree in any discipline from a recognised University. The candidates applying for the post of Station Officer (Fire Service) must be a Science or Engineering Graduate. The candidates who have not taken Odia as a subject in H.S.C standard must possess requisite certificate of passing ME standard in Odia as language subject.
- Physical eligibility criteria:** As prescribed in the clause-8(ii) of the detailed advertisement. PWD candidates are not eligible to apply for the post.

OPTION: Candidates may exercise their option for different posts in order of preference. Only Male candidates are eligible for the post of S.I. of Police Armed & Station Officer Fire Service. Only candidates having Graduation in Science or Engineering can opt for the post of Station Officer Fire Service. The Female candidates are eligible for the post of S.I. of Police and Asst. Jailor.

PLAN OF EXAMINATION : The recruitment process consists of **Preliminary Examination, Physical Test, Main Written Examination, Assessment of weightage marks** from NCC 'B' & 'C' Certificate, Winning Medal in National/International Sports events etc. & **viva-voce Test**. Detailed plan of examination is at clause-8 of the advertisement.
