- i) Date of ACTIVATION of the Online Application for the post will be notified shortly. Candidates are advised to be in constant touch with the above website to apply for the post.
- ii) Candidates are required to apply through Online Mode only after publication of detailed Advertisement in the website of the Commission. No Hard copy of the online Application is required to be sent to OSSC. However the DAF (OSSC Copy along with self attested photocopies of all required documents) are to be submitted at the time of certificate verification.
- iii) The candidates applying for the post must go through the detailed Advertisement and ensure that they fulfil all the eligibility criteria prescribed for the post as laid down therein. Admission of a candidate for the written examination & other Tests shall be provisional and would be on the basis of the information furnished by him/her in the Online Application form only.
- iv) If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her online application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria for the post, his/her candidature for the Post/Examination will be cancelled forthwith and he may be debarred either temporarily or permanently from appearing any further recruitment examination (s) conducted by Odisha Staff Selection Commission.

NO. OF VACANCIES: Total: Junior Assistant-19, Junior Clerk-75, and Junior Accountant-01

Detail category wise vacancy position and vacancies reserved for Special category will be notified in the detailed Advertisement.

Note: The number of vacancies to be filled up on the basis of this recruitment are subject to change as per discretion of the Commission/ Requisitioning Authorities /Government.

SCALE OF PAY: The appointment to these posts will be initially on contractual basis carrying a consolidated pay comprising of initial pay of Rs.5,200/- + Grade pay of Rs.1900/- (For Junior Assistant & Junior Clerk) and initial Pay of Rs.5200/- + Grade pay of Rs.2400/- (For Junior Accountant) in the scale of Rs.5,200/- to Rs.20,200/- (Pre-revised) subject to revision by the Government of Odisha from time to time as per Odisha Group-C & Group-D Posts (Contractual Appointment) Rules, 2013 notified vide Govt. in G.A. Department Notification No.32010-GAD-SC-RULES-0009-2013/Gen dated 12th November 2013.

CONDITIONS OF SERVICE: The Condition of Service shall be governed by respective recruitment rules/ orders of Government.

ELIGIBILITY:

- i) **Age:** Must not be below 18 years and above 32 years of age as on 01.01.2017. The upper age limit is relaxable by 5 years in case of ST, SC, SEBC and Women candidates, 10 years relaxation in case of PwD category candidates, by the period of qualifying years of service rendered in Defence Forces in case of Ex-Servicemen Candidates. The In-Service Contractual Employees must be less than 45 years as on 01.01.2017. PwD candidates in the ST & SC category candidates shall be entitled to avail cumulative age relaxation of ten years over & above the normal relaxation specified for the category.
- ii) **Educational Qualification:** Candidate in order to be eligible for the post of Junior Assistant & Junior Clerk must have passed +3 in Arts/ Science/ Commerce in any discipline or an equivalent qualification from a recognised University with knowledge in Basic Computer Skills. Candidates must have passed +2 in any discipline (Science/Commerce/Arts) or equivalent qualification from a recognised institution with Computer knowledge are eligible to apply for the post of Junior Accountant.

PLAN OF EXAMINATION: 1. Preliminary Examination, 2. Main Written Examination, 3. Computer Practical Skill Test.
4. Certificate Verification.

EXAMINATION FEE: The candidates other than SC, ST, & PwD category candidates shall have to pay non-refundable examination fee of Rs.100/- through Treasury Chalan either through online mode or through offline mode in the head of Account, "0051-PSC-104-UPSC/SSC-Examination Fees-0047-Fees collected for conducting examinations-02041-Examiantion Fees".
