Indicative Advertisement for Combined Recruitment to 03 posts of Weaving Supervisor and 01 post of Superintendent (PMF) Artist on contractual basis under Director of Textiles, Odisha, Bhubaneswar.

IMPORTANT:

- Date of activation of the Online Application for the post will be notified in the Detail Advertisement. Candidates are advised to be in constant touch with the above website to apply for the post.
- No Hard copy of the online application is required to be sent to the Commission. The documents as required are to be uploaded while filling up of the application form and self attested copies of all requisite documents/certificates are to be submitted at the time of certificate verification.
- The candidates applying for the post must go through the Detailed Advertisement and ensure that they fulfil all the eligibility criteria prescribed for the post as laid down therein. Admission of a candidate for the written examination & other Tests shall be provisional and would be on the basis of the information furnished by him/her in the Online Application form only.
- If at any stage of recruitment or thereafter, it is found that any information furnished by the candidate in his/her online application is false/incorrect or the candidate has suppressed any relevant information or the candidate otherwise does not satisfy the eligibility criteria prescribed for the post, his/her candidature for the Post/Examination will be cancelled forthwith and he/she may be debarred either temporarily or permanently from appearing any further recruitment examination (s) conducted by Odisha Staff Selection Commission.

NO. OF VACANCIES: I. Weaving Supervisor- Total -03 (w-02) {(SC - 01 (w-01), ST - 02 (w-01)}

II. Superintendent (PMF) Artist – Total-01 (w-nil) {(ST – 01 (w-nil)}

VACANCIES FOR SPECIAL CATEGORY: There is no vacancy reserved for Special Categories such as PwD, Ex-Servicemen & Sports Person. However, PwD category candidates having disability of 40% or more in the Benchmark Disability of Deaf & Hard of Hearing (Category-II) with suitable aid are eligible to apply for both the posts to avail age relaxation as per Clause-8 of SSEPD Resolution No.7140 dated 05.09.2017.

SCALE OF PAY & CONDITION OF SERVICE: The service condition shall be guided by Odisha Group-B Posts Contractual Appointment Rules,2013. The appointment will be initially on contractual basis carrying a consolidated pay of Rs.16,880/- per month (for 1st year) as per Odisha Group-B Posts Contractual Appointment Rules,2013 notified vide Government in GA Department Notification No. 1147-GAD-SC-RULES-0061-2013/Gen dated 17th January 2014 and as amended vide Government in GA & PG Department Notification No.GAD-SC-RULES-0037-2017-19569/Gen. Dtd. 12th Sept. 2017.

ELIGIBILITY:

- Age:**
 - Weaving Supervisor- Candidates must not be below 20 years and above 32 years of age as on 01.01.2019.
 - Superintendent (PMF) Artist - Candidates must not be below 21 years and above 32 years of age as on 01.01.2019.

The upper age limit is relaxable by 5 years in case of SC, ST & Women candidates, 10 years relaxation in case of PwD category candidates, the period of service rendered in Defence Forces in case of Ex-SM Candidates and upto 45 years as on 01.01.2019 in case of In-Service Contractual Employees subject to condition that he/she has completed one year of continuous service prior to commencement of the above Rule. PwD candidates in the ST & SC category shall be entitled to avail cumulative age relaxation of ten years over & above the normal relaxation specified for the category.

- Educational Qualification:**
 - Weaving Supervisor: The candidate must have passed Diploma in Handloom Technology/ Textile Technology from IIHT or other recognized Institutions.
 - Superintendent (PMF) Artist - The candidate must have passed Degree in Fine Arts and Crafts from recognized Universities/ recognized Institutions/Govt Institutions.

The applicant must have Odia as one of the subjects in the HSC or passed examination in Odia equivalent to M.E. standard or passed in Odia as language subject in final examination of Class-VII or passed a test in Odia in M.E. School Standard conducted by Education Department Govt. of Odisha on the date of the Application. Candidates as per their educational qualification may apply either of the post.

iv) PLAN OF EXAMINATION:

- Main Written Examination -200 marks (Paper-I – Composite Paper – 100 marks- 1 hour, Paper-II – Technical Paper – 100 marks - 1^{1/2} hours). There shall be negative marking @0.25 marks for each wrong answer in Paper-II only.

There shall be two different Technical Papers for Weaving Supervisor and Superintendent (PMF) Artist as per the syllabus prescribed for each post. For Detail Syllabus refer to detail advertisement.

- Certificate verification- Candidates numbering 05 times of vacancy for each category for different posts basing on the total marks secured in Paper-I and Paper-II taken together shall be called for Certificate Verification.

Select List: The Merit list of the candidates who have appeared in the certificate verification and found suitable shall be prepared basing on the sum total of marks secured in Paper-I and Paper-II of Main Written Examination. Two separate Merit List will be prepared for both the posts separately taking the marks secured in the Composite Paper and Technical Paper prescribed for each post. The select list in order of merit category wise shall be published from the respective Merit list of each post which will be equal to the number of vacancies notified in the advertisement.
