



**Corrigendum to the Advt.No 4428/OSSC Dt. 28.09.2015

Pursuant to submission of revised requisition by the Director T.E. & SCERT, Odisha, Bhubaneswar, vide L.N. 7061 dated 14.10.2015 & L.N.7204/STS dated 19.10.2015, the Educational qualification for the post of Art Instructor appearing at SL. Besides the vacancy position of the art instructor appearing at Sl no. 13 of clause 3 of the advertisement is also revised as per above qualification.

H- Work performed by hearing /Speaking.


The PWD persons are not eligible to apply for the post of Physical Education Instructor.
