

 6. Certificate & mark sheet of the minimum required educational qualification specified for the post as per Corrigendum Notice No.4030/OSSC dtd.30.12.2014 .
 7. Candidates of SC/ST category shall bring caste certificate issued by the competent authority for the purpose of employment.
 8. Candidates claiming reservation under SEBC category shall bring valid SEBC certificate issued by the Competent Authority.
 9. Discharge certificate, identity card and the document indicating the period of service rendered in defence forces in case of Ex-Servicemen candidates.
 10. Disability certificate issued by competent authority in case of persons with disability.
 11. Certificate either of passing HSC examination with Odia as a compulsory subject, or in lieu thereof a certificate of passing Odia of M.E. standard issued by competent authority.


