- Candidates on the basis of the information filled in the online application form will be allowed for the written examination and if at any stage it is found that he has furnished false or incorrect information his/her candidature will be rejected forthwith.
- Only the qualified candidates in the written examination shall have to submit DAF as per clause-7 of the advertisement at the time of certificate verification in the Office of Commission.

CONDITIONS OF SERVICE: Appointment is guided by the respective recruitment Rules if any & the Odisha Group-B (Contractual Appointment) Rules, 2013. Appointment will be initially on contractual basis.

ELIGIBILITY

- Age Must not be below 21 years and above 35 years of age as on 1.1.2015.
- Upper age relaxation limits 5 years in case of ST, SC, SEBC and Women candidates, 10 years relaxation in case of PWD category candidates, the qualifying years of service in Defence Forces in case of Ex-SM, and below 45 years as on 01.01.2015 in case of In-Service Contractual Employees.
- Educational Qualification: Must have secured minimum 50% marks in Post Graduate Degree level in any discipline of the Social Sciences (such as Education/Phylosophy/Sociology/Psychology/History/Geography/Pol.Science/Economics)/Master Degree in Science (Physics, Chemistry, Botany, Zoology, Computer Science) /Mathematics/Odia/English/Hindi/Sanskrit along with 50% marks at M.Ed. level from a recognised University. The candidates applying for the post of Physical Education Instructor/ Art Instructor must have Master Degree in Physical Education (MPed) and Master Degree in Fine Arts respectively with minimum 50% marks. Refer to advertisement for details of educational qualification and post configuration.

OPTION: Candidates as per his/her qualification at Master Degree level may opt for only one type of the post in any discipline i.e. for the post of Teacher Educator in Fundamental courses or in pedagogy courses such as Science (Physics Chemistry Botany Zoology/Computer Science) Mathematics History Geography Economics Pol.Science Odia/English/ Hindi/ Sanskrit or for Physical Education Instructor Art Instructor.

PLAN OF EXAMINATION The recruitment process for the post of Teacher Educator consists of Written Examination of 350 marks in three papers. Two compulsory papers of 200 marks & one optional paper of 150 marks. For details the candidates are advised to refer to Clause-8 of the Advertisement. The Syllabus of examination for the post of Physical Education Instructor & Art Instructor will be notified later.

CERTIFICATE VERIFICATION: Candidates about two times of the posts advertised after qualifying in the written examination shall be shortlisted category wise in order of merit for verification of original certificates at the Office of Commission.

EXAMINATION FEES Rs.100/- (can be remitted online through Odisha Treasury Portal (e-chalan) or Treasury Chalan in any Treasury/Sub-Treasury under the Head of Account "0051-PSC-104-UPSC/SSC-Examiantion Fees-0047-Fees collected for conducting examinations-02041-Examiantion Fees" . The ST,SC & PWD category candidates are exempted from paying any examination fee.
