Online Applications are invited by using website 'www.ossc.gov.in' for the Teacher Educator Examination-2015 for selection of candidates for recruitment to 143 Post of Teacher Educator, 10 posts of Art Instructor & 33 posts of Physical Education Instructor in different ETEIs (Elementary Teacher Education Institutions) and BITEs (Block Institutions of Teacher Education) under School & Mass Education Department Govt. of Odisha. The posts will be initially on contractual basis as per Odisha Group-B posts (Contractual Appointment) Rules, 2013 in the Pay Band-2 i.e. Rs.9,300-34,800/- with Grade Pay Rs.4200/-.

Caution: 1. The candidates applying for the post must go through the advertisement and ensure that they fulfil all the eligibility criteria/conditions prescribed for the post/examination as laid down in this advertisement. Admission of a candidate for the Written Examination & certificate verification shall be provisional and would be on the basis of the information furnished by him/her in the on-line application. - 1(b) Candidates are required to visit the website of the Commission 'www.ossc.gov.in' and then required to click the tab 'online application' in the home page of the website, the posts advertised for online application and detailed instructions for submitting the application online are displayed on the computer screen. These Instructions along with the instructions in this advertisement are to be read carefully before proceeding to fill up the Application Form. The Application Form can be generated

by clicking on 'apply online' after selecting the post. Here the system will ask to furnish the 10th/HSC Examination Roll number, name of the Board & year of Passing and whether Annual or Supplementary. Syllabus

2 hours duration: 100 Marks Paper -I- General English

The questions in this paper will be of Graduate Degree standard carrying a maximum mark of 100, including 50 marks for an Essay. The remaining 50 marks are intended to

10. PLACE AND DATE OF WRITTEN EXAMINATION:

The date/time/ venue of the Written Examination & Certificate will be intimated to the eligible candidates in the admission letters, in due course which will be downloaded by the eligible candidates by accessing the Commission's website from a date to be notified later. The list of admitted & rejected candidates shall be displayed in the said website in due course.

11. Admission letter:-

The Commission shall upload the Admission letter of this recruitment examination at different stages (Main Written Exam /Certificate Verification) of the admitted candidates on its Website. "www.ossc.gov.in". Alert message regarding different stages of the examination will also be sent to the admitted candidates at different stages. As such the candidates have to log on to the website of the Commission by clicking on the button 'candidate's login' and

then provide 'user Id' and 'password' upon which the status of the application will be displayed on the screen. If the application has been rejected the same would be indicated along with grounds of rejection. Then the eligible applicant has to click on "Download Admit Card" and the requisite Admission letter can be downloaded. The candidates are advised—to download their respective Admission letters and take print out thereof. The admitted candidates will have to produce the admission letter at the allotted venue for appearing in the examinations/tests. The admission letter will carry intimation about the date, time and venue of the examination, and will bear the photo and signature of the candidate with facsimile signature of the Secretary of Commission.

No Admission Letter/ call letter at any stage will be despatched to any candidate by post.

12. Selection Procedure

A Merit list shall be prepared basing on the marks secured in the Written Examination. The candidates after verification of original certificates shall be selected category wise in order of merit for different posts as per their option exercised/qualification at Master Degree level exactly the same number of vacancies advertised for each Stream for sponsoring the same to respective requisitioning authorities.

The results will be published in due course in the Commission's website.

- NOTE:-i. Blue/Black ball point pen only shall be used for answering (ovalling) in OMR sheet; whiteners/erasers shall not be used in the OMR sheet.
