- iii) Minimum Educational Qualification:-The candidate must have passed ITI from any institutions affiliated to NCVT or Degree/Diploma from AICTE approved institutions of relevant trade with teaching experience(3 years for ITI/2 years for Diploma/1 year for Degree candidate)from any institution affiliated to AICTE/NCVT). Experience certificate not submitted along with the DAF or obtained after the last date of submission of application form shall be rejected.

Separate exam. will be held for ITI & Degree/Diploma candidate.
