CONDITIONS OF SERVICE: Appointment is contractual initially to be guided by the Odisha Group-C & Group-D (Contractual Appointment) Rules, 2013 notified vide G.A. Department Notification No. GAD-SC-Rules-0009-2013-32010/Gen dt. 12.11.2013.

ELIGIBILITY

- i) Age: - must not be below 21 years and above 32 years as on 1.1.2017.
- ii) Upper age relaxation:- 5 years in case of SEBC,SC,ST, and Women candidates. 10-years for PwD Candidates and total period of service rendered in Defence Services in case of Ex-Service Men category.
For in-service contractual employees as per provisions contained in the concerned Rules, they must be within 45 years of age as on 01.01.2017.
The upper age limit (i.e. below 45 years of age as on 01.01.2017) in respect of existing members of Watershed Management Team, Watershed Development Team, Livelihood Support Team, Capacity Building Team and Technical Experts Team is relaxed as per instruction issued by Government and they are allowed to apply for the post.
- iii) Minimum Educational Qualification: - Candidates having +2 Science or +2 Vocational Courses in Agriculture related subject i.e., Crop Production (CP)/Horticulture/Repair & Maintenance of Power Driven Farm Machinery (PDFM) from any of the recognised Board/Council or Institution are eligible to apply for the post.
